## About the Speaker



Ambassador Michael Oren served as the Israeli Ambassador to the United States from 2009 to 2013. The Ambassador worked on several important projects during his tenure, including the Iran nuclear threat and Israel's Iron Dome defense system. He received the Statesman of the Year Medal from the Washington Institute for Near East Policy and the Dr. Martin Luther King Legacy Prize for International Service for his role as Ambassador to the U.S.

Before his time in government, the Ambassador served in the Israeli Defense Forces, fighting in the Lebanon War, and later served as an army spokesman in other conflicts.

Ambassador Oren's work in foreign policy has also included serving as Deputy Prime Minister for Diplomacy after his election to the Israeli Legislature, working as an advisor to Israel's U.N. delegation, and representing NGOs abroad in defense of Israeli people and companies.

Ambassador Oren has written many books, appeared across the media, and authored opeds and essays for, among others, the New York Times, Wall Street Journal, and the Atlantic. He is

also the founder of the Israel Advocacy Group, a global organization that works to strengthen Israel's relationships.

Ambassador Oren holds degrees from Princeton and Columbia, has lectured at Harvard, Yale, and Georgetown, and has received fellowships from the American, British, and Canadian governments.
