- What does the acquisition pipeline look like in N.A.? What type of return profile do you target on deals?
- What is the likelihood that you would make an acquisition that is transformational in size? Anything outside of railcar leasing / services?
- What are some of the topics we should expect to hear about at the investor day? Plans to provide long term targets?
